D. Public Hearings -

1. Special Franchise Agreement - Spectrum

Supervisor Castellucci opened the Public Hearing and reviewed that this is the first agreement in ten years due to the change from Charter to Spectrum etc. Councilmembers Jochum and Marks asked a few questions. Attorney Graven stated that it is almost the same as the last agreement which is typical for municipalities. The few changes involved limiting free streaming to schools and some minor verbiage modifications. There was no one wishing to speak. **Councilmember Morgan made a motion to close the Public Hearing. The motion was seconded by Councilmember Jochum and unanimously carried.** Another motion was made by Councilmember Morgan to adopt the following resolution and authorize the Supervisor to sign the agreement. The motion was seconded by Councilmember Marks and unanimously carried.

WHEREAS, an application has been duly made to the Board of the Town of Owego, County of Tioga, New York, by Spectrum Northeast, LLC, an indirect subsidiary of Charter Communications, Inc. ("Charter"), a limited liability company organized and existing in good standing under the laws of the State of Delaware doing business at 2604 Seneca Avenue, Niagara Falls, NY 14305, for the approval of a renewal agreement for Charter's cable television franchise for ten (10) years commencing with the date of approval by the Public Service Commission; and

WHEREAS, the franchise renewal agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings; and

WHEREAS, a public hearing was held in the Town of Owego, New York on Tuesday, June 20, 2023 at 6:30 PM and notice of the hearing was published in the Press & Sun-Bulletin on June 11, 2023;

NOW, THEREFORE, be it resolved that the Town of Owego finds that:

1. Spectrum Northeast, LLC has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and

2. Spectrum Northeast, LLC has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and

3. Spectrum Northeast, LLC can reasonably meet the future cablerelated community needs and interests, taking into account the cost of meeting such needs and interest.

AND BE IT FURTHER RESOLVED that the Board of the Town of Owego hereby grants the cable television franchise of Spectrum Northeast, LLC and the Town of Owego for ten (10) years commencing with the date of approval by the Public Service Commission and expiring ten (10) years hence; and

BE IT FURTHER RESOLVED that the Board of the Town of Owego hereby confirms acceptance of this franchise renewal agreement and authorizes the town supervisor to sign said agreement. E. Reports of Department Heads -
