## RESOLUTION AUTHORIZING THE TRANSFER OF SURPLUS PROPERTY TO TIOGA COUNTY SUBJECT TO PERMISSIVE REFERENDUM AS PERMITTED BY LAW

WHEREAS, the Town of Owego Highway Department has relocated operations to the Shared Services Facility situate at 2272 State Route 434; and

WHEREAS, their former facility located at 70 Delphine Street in the Village of Owego (Tax Map No. 128.07-1-7) is now vacant; and

WHEREAS, the Tioga County Department of Public Works has approached the Town of Owego with an offer to purchase the former facility at 70 Delphine Street for \$200,000.00 (Two-hundred thousand dollars);

NOW, THEREFORE, BE IT

RESOLVED, that the former highway facility located at 90 Delphine Street is no longer necessary for the Town to retain for Town purposes and is hereby declared by the Town Board to be surplus property; and be it further

RESOLVED, that the Town of Owego Supervisor Donald Castellucci is authorized to sign any and all documents necessary to sell the above property to Tioga County for the amount of \$200,000.00 (Two-hundred thousand dollars), subject to permissive referendum as permitted by law.

AND BE IT FURTHER

RESOLVED, that the Town Board has determined that it wishes to retain Coughlin & Gerhart Law Firm to provide legal services to complete the transaction.

Councilwoman Grenier seconded the motion and it was unanimously carried.
